**ORDER**

At its September 2022 session, the Judicial Conference approved changes to the maximum per page original and copy transcript fee rates for fiscal years 2024 and 2025. At its September 2023 session, the Judicial Conference modified the transcript category names to ensure clarity regarding delivery timing and to help alleviate confusion concerning related costs and fees.


Pursuant to these Judicial Conference authorizations the following rates and descriptions shall apply for court transcripts in this District on the effective dates set forth below.


<b>Original Transcript Rates</b>		
<b>Transcript Type</b>	<b>Fiscal Year 2024 Effective 10/01/2023</b>	<b>Fiscal Year 2025 Effective 10/01/2024</b>
<b>30-Day Transcript (Ordinary)</b> A transcript to be delivered within thirty (30) calendar days after receipt of an order.	\$4.00	\$4.40
<b>14-Day Transcript</b> A transcript to be delivered within fourteen (14) calendar days after receipt of an order.	\$4.70	\$5.10
<b>7-Day Transcript (Expedited)</b> A transcript to be delivered within seven (7) calendar days after receipt of an order.	\$5.35	\$5.85


<b>3-Day Transcript</b> A transcript to be delivered within three (3) calendar days after receipt of an order.	\$6.00	\$6.55
<b>Next-Day Transcript (Daily)</b> A transcript to be delivered on the calendar day following receipt of the order (regardless of whether that calendar day is a weekend or holiday), prior to the normal opening hour of the clerk's office.	\$6.70	\$7.30
<b>2-Hour Transcript (Hourly)</b> A transcript of proceedings to be delivered within two (2) hours from receipt of the order.	\$8.00	\$8.70
<b>Realtime Transcript</b> A draft unedited transcript produced by a certified realtime reporter as a byproduct of realtime to be delivered electronically during proceedings or immediately following receipt of the order.	One Feed, \$3.40; Two-to-four feeds, \$2.35; Five or more feeds, \$1.65.	One Feed, \$3.70; Two-to-four feeds, \$2.55; Five or more feeds, \$1.80.
