REPORT TO THE COURT by Magistrate Judge Juliet E. Griffin Pursuant to this Court's Order entered 1/23/95 [25-1], [25-2], the Magistrate Judge directed the defts to prepare a proposed pretrial order to be forwarded to the pltf in advance of the pretrial conference, and directed the pltf to bring to the pretrial conference his own statement of his theory of the case. In addition, both parties were directed to bring to the pretrial conference their lists of witnesses expected to be called at trial and exhibits proposed to be introduced at trial. (Order entered 2/2/95, DE No. 27) On 2/8/95, the defts submitted a proposed pretrial order, and filed their witness and exhibit list. At the pretrial conference on 2/13/95, the pltf submitted a list of witnesses that he wanted to call at trial and an explanation of the exhibits he wished to tender at trial. At the conclusion of the pretrial conference on 2/13/95, the Court directed the defts to submit a revised pretrial order, which was submitted on 2/21/95, and to which was appended copies of the exhibits that the defts propose to introduce at trial. Attached hereto is a pretrial order submitted by the Magistrate Judge for the Court's consideration in this case scheduled for trial on 3/13/95.
