Attached is an application to practice before the United States District Court for the Middle District of Tennessee. Please carefully follow the following instructions:

- 1. Complete all fields in the application.
- 2. The state bar information provided will be verified. If you are not a member of the Tennessee Bar, please attach a certificate of good standing from a U.S. District Court or U.S. Appellate Court. **State bar certificates of good standing do not meet this requirement.**
- 3. The two attorneys who recommend you for admission must be admitted to practice before this Court and must sign the application.
- 4. All applicants must register using an individual, upgraded PACER account. Applications cannot be submitted using a legacy or shared PACER account. For additional instructions:
- 5. You may also hand-deliver or mail the completed application, along with the required **application fee of** \$249.00, to Clerk's Office, 719 Church Street, Suite 1300, Nashville, TN 37203.
- 6. Upon receipt of your application, the Clerk's Office will determine whether your application complies with Local Rule of Court 83.01.
- 7. If your application is approved, you will receive an e-mail confirming approval along with additional instructions regarding the date, time, and location of the admission ceremony where you will be sworn in by a District Judge. You must be admitted to practice within six (6) months from the date your application is approved.
- 8. An attorney who is admitted to practice before this Court **MUST** accompany you to the admission ceremony to introduce you in open Court. This attorney is not required to be one of the two attorneys who signed your application for admission.
- 9. On the day of your scheduled admission ceremony, please report directly to the assigned courtroom at least fifteen minutes prior to the designated start time.
- 10. After admission, you must go to the Clerk's Office to sign the Court's Bar book and receive your certificate to practice. Please bring your application for admission with you.
- 11. After admission, you must register online to receive CM/ECF login credentials. The registration page can be found on the Court's website at: https://www.tnmd.uscourts.gov/content/register-cmecf-account
